Taking the ESG standardization as the core, the summit will solicit opinions on the "ESG Disclosure Guidelines for Apparel and Textile Enterprises" and interpret the logical framework and application approach of this standard from the aspects of current ESG development, ESG challenges faced by textile and apparel enterprises, the importance of unifying ESG disclosure standard on the industrial level and ESG disclosure practices. The forum will discuss the significance of standardized, systematic, characteristic and quantifiable ESG information for regulators, capital markets and social communication from a diversified and cross-industries perspective. In doing so, it will put forward a path for Chinese enterprises to improve compliance quality, accelerate sustainable transformation, explore business opportunities, enhance social impact and achieve high-quality development under the global ESG wave, and establish global ESG best practices of Chinese textiles.
